

FLP Warranty

Greenseal EPDM Rubber Reservoir, Pond liners & Tank Liners.

a) We warrant Greenseal EPDM Rubber lining to have a useful life of twenty five years (ten years for tank liners, ten years for box welded liners) as a waterproof barrier under normal use and service for which it is designed and manufactured in any customary weather conditions which may be encountered and which are not customarily considered to be in the nature of disaster or catastrophe such as (but not limited to) earthquake, flood, piercing hail, tornado etc. Normal use and service excludes, among other things, exposure of the lining to harmful chemicals, temperatures, mechanical damage by machinery, equipment or persons or excessive stresses or pressures from any source.

Any claim for alleged breach of warranty must be made and presented to the Company within thirty days of the alleged defect occurring or the warranty will be deemed to have been waived by the customer.

The Company's liability under this warranty will in no event exceed the amount of the sale price of the material sold to the customer for the particular installation for which it failed and in no circumstances will the Company be held liable for any consequential or special damages either direct or indirect arising from loss of production or any other losses owing to the failure of the material.

No allowance will be made for repairs, replacements or alterations made by the customer unless with the express permission and consent of the Company.

This warranty will only be valid for Greenseal Rubber EPDM rubber installed without stress (elongation) placed upon the material.

b) Where the customer within the United Kingdom deals with the Company as a consumer as contemplated by the Unfair Contract Terms Act 1977 or the Sale of Goods Act 1979, nothing here in contained will in any way restrict or interfere with the buyer's right under the Supply of Goods (Implied Terms) Act 1973 or the Sale of Goods Act 1979 or any Statutory re-enactment or amendments thereof.

c) In the case of the sale or supply of goods to a customer outside the United Kingdom, or where the customer does not deal with the Company as a consumer, the Company will not be responsible for and gives no express or implied warranty or representation and no warranty or condition shall be implied relating to the suitability or fitness of the goods for use with any particular product or in any particular Circumstance or for any particular purpose or as to their condition or merchantability save as set out above.

WARNING

Do not be misled by some companies offering more than 25 years guarantee as it is merely a marketing ploy. Under UK law a "lifetime" for this material equates to 25 years hence anything contrary to this is basically worthless. Our Lifetime Guarantee is valid irrespective of whether you use our geotextile (or not), sand or carpet as a protective underlay. Do not be coerced into thinking if you do not buy underlay then the guarantee would not be valid. (selling ploy)
